Johannes was educated at Lausanne and Berne universities (state exam, 1998; Dr. iur., 2001, summa cum laude) and at Stanford Law School, U.S.A. (LL.M. in Corporate Governance and Practice, 2003). He served as Chairman of the Board of Directors and Chairman of the Executive Board of Walder Wyss Ltd. from 2013-2021.
