Dario was admitted to the Bern bar in 2017. He is registered with the Zurich Bar Registry and admitted to practice throughout Switzerland.

Before joining Walder Wyss as an associate in 2018, Dario worked as a judicial intern at the District Court for the District of Emmental-Oberaargau in Burgdorf, Switzerland (2014–2015) and as a junior associate (2015–2016) as well as a legal employee (2016–2017) at Walder Wyss.
